IMPORTANT FOR TAX EXEMPTION: New York State Law requires, that your registration form must be accompanied by an original, **ST-119.5 Tax Exemption on Hotel or Motel Occupancy by Representatives of Veteran's Organizations**, form, in order to receive tax exemption. The form must be an original and be signed both by you (the representative) and an officer of the veterans post or organization (who must be an officer other than the representative.) Failure to do so will result in charges for New York State and local taxes.

After the group cut off date, the group rate quoted will no longer be available and all charges will reflect prevailing rates. Any and all cancellations made less than seven (7) days prior to arrival will be subject to the forfeiture of the individual's deposit.
